**GERMAN CHANCELLOR ANGELA** Merkel gained a political suitor as a pro-business party vies for her favour on the expectation she'll win another term in a national election on September 24.

Christian Lindner, head of the Free Democratic Party that's campaigning to re-enter parliament after a four-year absence, told Sunday newspaper *Bild am Sonntag* that he foresees a Merkel victory over Social Democrat Martin Schulz.

In that case, the party that finishes third would be a gauge of the national mood, said Lindner, whose FDP was Merkel's coalition partner between 2009 and 2013.

With Merkel's Christian Democrat-led bloc ahead by as many as 18 percentage points, polls suggest a neck-and-neck race for third place between the
