- 1. #### NOTES TO THE UNAUDITED FINANCIAL RESULTS

- The Unaudited financial results of National Standard (India) Ltd. ("the Company") for the quarter ended 30-June-21 have been reviewed by the Audit Committee and approved by the Board of Directors at its meeting held on 20-July-21, The financial results for the quarter ended 30-June-21 have been subjected to limited review by the Statutory Auditor of the Company who have expressed an unmodified opinion.
- Disclosure under Ind AS 108 on 'Operating Segment' is not applicable as the Company has only one reportable seament which is real estate development.
- During the earlier year, the Company received a LBT (Local Body Taxes) demand of ₹ 37.79 Lakhs and equal amount of penalty under Rule 40 of the Local Body Tax Rules. The Company had deposited the LBT demand of ₹ 37.79 Lakhs with the relevant authorities. An appeal has also been filed by the Company with the Thane Municipal Corporation against the demand order. No provision has been made for the penalty, as the management is confident that the outcome would be favourable and no further liability is likely to occur.
- The Company is evaluating Business Options which will ensure utilization of the unutilised input tax credit of ₹ 240.79 Lakhs as on 30-June-21.
- The Company's operations were impacted by the Covid-19 pandemic. In preparation of these results, the Company has taken into account internal and external sources of information to assess possible impacts of the pandemic, including but not limited to assessment of liquidity and going concern, recoverable values of its financial and nonfinancial assets and the impact on revenues. Based on current indicators of future economic conditions, the Company has sufficient liquidity and expects to fully recover the carrying amount of its assets. Considering the evolving nature of the pandemic, its actual impact in future remain uncertain and could be different from that estimated as at the date of approval of these financial results. The Company will continue to monitor any material changes to future economic conditions.
- The Company has temporarily deployed its project surplus which had resulted in it being classified as Non-Banking Finance Company (NBFC) during the year ended 31-March-20 in terms of the Principal Business Criteria (PBC) laid down by the Reserve Bank of India (RBI). The RBI had advised the Company to take necessary steps to reduce its financial assets to avoid being classified as NBFC. During the year 31-March-21, the Company did not qualify under the PBC and the same has been informed to RBI.
- The statement include the results for the quarter ended 31-March-21 being the balancing figure between the audited figures in respect of the full financial year ended 31-March-21 and the published unaudited reviewed year to date figures up to nine months ended 31-December-20.
- The previous period's/year's figures have been regrouped, re-arranged and reclassified wherever necessary to conform to current period's presentation.
